A Loaned Executive assists the United Way in planning, organizing and managing 6-10 workplace campaigns. Hours are varied and flexible.

Prior to assignment, Loaned Executives participate in a one-day training in July to focus on enhancing the following skills:

- ◆ Presentation
- ◆ Sales
- ◆ Team work

The ideal Loaned Executive is someone who is **enthusiastic, organized, a self-starter,** and a **positive, community-minded person.**
