WE ARE BETTER TOGETHER!

THANK YOU so much for your continued partnership and leadership support! For more than 100 years, United Way has remained committed to serving the community through triumphs and challenges. We remain United in Purpose to bring the community together to solve local problems that impact the well-being of our families and help build a thriving community right here at home. Together, we accomplished so much! Here are some of our accomplishments from 2023, made possible by your partnership and leadership support.

EDUCATION: We made progress to ensure every child achieves Success by Six and is Career Ready by 21, our prevention work!

- 150 youth were engaged in specific career readiness training and internships, while hundreds more were engaged in high quality afterschool programming to stay on track, build STEM skills and character.
- Dolly Parton's Imagination Library is currently engaging over 6,000 children and families in Muskegon, Newaygo and
 Oceana counties by sending a book each month to their homes. 74% of parents reported reading daily with their child
 and 100% reported reading more frequently a key indicator of kindergarten readiness. We were chosen by the state to
 help implement a regional effort for other birth to 5 literacy programming.
- 30 children were prepared to learn through a Retired & Senior Volunteer Program (RSVP) piloted last year that matched volunteer tutors to review letter sounds with kindergartners in two schools on a daily basis. This fall, we are doubling the program by adding two more schools. Volunteers needed!
- Our United Way secured a planning grant to conduct a deep dive on the needs of families, businesses and childcare
 professionals to improve the childcare delivery system in our region. The results of our plan will be released soon.
 Through our advocacy, we championed public policy efforts to improve childcare subsidies for working ALICE families
 and childcare providers to improve worker retention.

INCOME STABILITY: We made progress on our work to create Safe & Stable Homes for children and families!

- Our new Housing & Homeless Network Coordinator position funded by grants helped ensure a smooth transition of our homeless prevention programming and grants. When one of our agencies went out of business, United Way assisted in vetting a new partner to assume this work and took on the management of the two federal HUD grants related to planning and data management. Due to better data management, our community is eligible for bonus funding!
- We received the report of the county-wide housing needs study in Muskegon County, learning that a staggering number of
 housing units, 9000, are needed over the next five years! Housing is the number one need in all three counties and
 significant efforts and partnerships are underway to help in this area.
- With the help of several partner agencies and our emergency needs staff, we helped stabilize hundreds of families through emergency crisis....maintaining family stability and keeping them connected to employment.

HEALTH: We made progress on our work to provide for the Health & Healing of our most vulnerable.

- We connected businesses and individuals to mental health services with concerns for the high level of trauma and crisis
 affecting so many families.
- Recognizing that we are two years away from the last year of our bold goal around ALICE, the board met to set clear
 priorities for the next two years to ensure we achieve that goal of lifting 10,000 more working families to meet their basic
 needs.

United Way of the Lakeshore program investments in 2023 were \$2.2 million with over \$900,000 going out to our nonprofit partner agencies in Muskegon, Newaygo, and Oceana counties, and another \$602,087 to partners and initiatives focused on our community solution priorities. Together this work focused on building thriving communities through education, financial stability, and health outcomes. 
WHEN COMBINED WITH THOSE LIVING BELOW THE FEDERAL POVERTY LEVEL, 4 in 10 HOUSEHOLDS ACROSS THE LAKESHORE ARE STRUGGLING TO MEET THEIR BASIC NEEDS.

It's no secret that people experiencing poverty have a hard time meeting their basic needs. But so do many families with incomes above the federal poverty level. These are ALICE households: Asset-Limited, Income-Constrained, Employed. Simply put, ALICE households earn too much to be considered poor, but not enough to cover the cost of living in their county.



ALICE represents men and women of all ages and races who go to work each day, but still face tough financial choices. ALICE is the person who frets over bills, skips meals, and always takes the extra shift. ALICE is glad to have a job, proud of their work, and happy to contribute to the community. But ALICE knows that one major financial setback—a car repair, an unexpected medical expense, a job loss—could push them into a desperate situation.

ALICE Rates Over Time:



Updates On ALICE Since Bold Goal

- Since 2015, wages have increased overall, the cost of living has outpaced it and risen by 24.7%. From 2019 to 2021, the
 Household Survival Budget's average annual costs (excluding taxes) increased 12% for a single adult, 9% for a single senior,
 and 8% for a family of four from 2019 to 2021.
- The average household size in Michigan is 2.46
- We saw 4,434 households move above the poverty line into ALICE (3,385 (M), 567 (N), 391 (O)).
- 1,649 families moved above the ALICE threshold since 2015 (677 (M), 189 (N), 783 (O).

Since our bold goal we have changed the odds for **14,964 individuals** (moving them above an income threshold).

Board set aside \$100K for new ALICE grants in 2016 for programs launched in 2017; 8 new agencies added.



2017 - Dolly Parton's Imagination Library Expands to Oceana

Dolly expands to Oceana County. Nichols 25K match, MAISD partners with a 28K contract. We invest into Read Early. Read Often.

2017 - Jobs for Michigan Graduates

DTE Summer Youth Internship program expands to add Jobs for Michigan Graduates in Muskegon Heights. The program is at \$200K with 150 youth engaged.



2018 - Reading Corps Pre-K Students Prove Program Concept

Students start from 9% national average in the year and improve to 16-26% ABOVE the national average. Read Muskegon starts 2-Gen Literacy programming.



2017 - Transportation Program Development

Several transportation programming options are developed in Muskegon, Newaygo, & Oceana County.

The COVID-19 Pandemic Begins.Benefits are expanded, thousands are recieving unemployment during the shutdown, businesses struggle to remain open. Thousands of individuals are also facing devasting health threats at the spread of the virus.

2020 - Emergency Fund Created & Community Emergency Relief Team Expands

Thousands of volunteers band to serve the community during the shutdown. Masks, emergency food, and supplies were being delivered and managed by volunteers. This includes health providers who served during the testing and vaccinations. United Way is in Disaster Relief Mode for 2 years.



2020 - Equity Work Expanded - DEI Statement Adopted by Board. Impact Strategy Team puts emphasis on disaggreagated data & disparities.

2020 - Emergency Housing

United Way becomes the source of emergency and immediate housing needs during the pandemic. Coordinating with shelters and the local hospitals to place individuals in temporary housing while being COVID-19 positive. This helped slow the spread and keep families living in safe housing.



2020 - Childcare Navigators Help Families Return to Work

2 childcare navigators help families apply for assistance and programming as they return to work during the pandemic.

2021 - Tri Share Program Launched & Y Learning Center Created.

Tri-Share Childcare pilot begins with Goodwill Industries. The Y Early Learning Center opens to serve infants through school aged children.



2022 - Tri Share Expanded, Childcare Regional Planning Grant Awarded

In late 2022, the Tri Share program was expanded by the state.

Announcement of receiving the Regional Childcare Planning
Grant is awarded to UWL for Lake, Mason, Muskegon, Newaygo,
and Oceana Counties. A Coordinator for this program to be hired
in 2023.



2022 - Mission United Adopted for Veteran Based Programming - Formalized programing to begin in 2023.

2022 - Muskegon Continuum of Care, the City of Muskegon, the County of Muskegon, & United Way Partner to Bring in a Homeless & Housing Coordinator for State/Federal Opportunities.

To help end homelessness.

2023 - Early Literacy Coalition Planning Grant Moves to United Way

Covers 13 counties in our north-west region. Our priorities are early literacy and child-parent engagement.



2023 - Public Policy Wins

\$4 Million in the State Budget for Dolly Parton's Imagination Library. Expansion of the Earned Income Tax Credit from 6 - 30%. Preschool for All expands statewide. Muskegon County Housing Assessment is completed.




